The new process allowed the staff and board to work together to review trends in the industry, our current programs, and the market, and to plan accordingly to diversify our offerings to continue to fulfill our mission in a meaningful way.

On behalf of the entire Board of Directors, I would like to thank the staff of the Children's Home for their hard work and dedication. I would also like to thank our many generous donors for their contributions, both financial and in-kind, that make the fulfillment of the mission possible.

Welcome to our 2012-2013 Annual Report! The Children's Home continues to evolve and change. Over the last year, some of our programs retired, while new programs and services emerged. But some things never change — like our unwavering commitment to families and children and our gratitude to our supportive community.

The Children's Home successfully treats children and families with extensive trauma in our array of services. We see firsthand how early childhood experiences influence lifelong outcomes. This past year, to improve early childhood experiences and prevent future trauma, the Children's Home began providing early development social work services. Children from birth to five years and their families who receive Early Intervention Services from the County now also have access to an extra layer of services to support their family.

We continue to enhance our foster care program. Through the amazing dedication of Children's Home's Permanency case workers and the partnership with resource families, children are placed in loving homes 24/7 — 365 days a year. Anytime, day or night, holidays and weekends! Our accessible team has provided solutions for children of all ages from newborns to older teens and even to large groups of siblings.

Over the past year, children achieved their unique goals; families were fortified; and 37 children secured the forever family they dreamed about. The Children's Home is about helping children and families. We're about home. A special thanks to all of you who help us make Home happen.

Our 2012-2013 annual report is dedicated to Dr. Thomas Schonauer.

Dr. Schonauer was a caring member of the Children's Home Board of Directors, who passed away in January 2014.

The Children's Home and the entire community are indebted to his years of service to the community.

# Evolution of Children's Home

The Children's Home of York was founded in 1865 when a group of caring citizens joined together to help children who were left homeless in the aftermath of the Civil War. For nearly 150 years, the goal of the Children's Home has remained the same — to serve children and families in need in our community.

We are able to maintain this goal because we are constantly changing to better meet the needs of children and families. The trend of care has changed, with many adolescents being placed in kinship or less restrictive care, rather than residential facilities. In 2013, the Board of Directors decided to close two programs — Tindall House for young boys and STRIVE for young men with addiction issues. Both buildings that housed the programs remain owned by the Children's Home and we continue to explore options to repurpose the buildings.

As some programs have closed, others are emerging. In 2013 the Children's Home launched an Early Development Program that addresses the needs of children from birth to age five years who are experiencing developmental delays. This was a need identified in our community to help children to thrive and families to strengthen. We also continue to expand our prevention services like Family Innovative Supporting Housing (FISH) for families facing homelessness and our Strengthening Families Program.



## Today's Children's Home

Children's Home of York is about helping children and families. We provide a variety of programs with trauma-informed care and support so children can learn the skills they need to reunify with their families.

When reunification is not an option for children in our care, we help find loving forever families for boys and girls from birth to 21 through foster care and adoption.

# BRIDGES™

BRIDGES™ is a partial hospitalization program for children and adolescents ages 11 to 19 who are experiencing severe psychiatric symptoms and emotional disturbance. BRIDGES offers a therapeutic milieu employing Sanctuary® principles and provides intensive, community-based treatment in conjunction with educational instruction from licensed Lincoln Intermediate Unit No. 12 teachers. Participants acquire the skills they need to transition out of the program to a less restrictive and less intrusive level of care. BRIDGES operates year-round and consists of highly-structured therapy and offers scholastic education in conjunction with treatment services during the school year.

*Reid began his Children's Home journey in January 2005; first as a Tindall House resident and then in foster care. He had a history of physical and sexual abuse and was abandoned by his family. His behavior became aggressive and sexualized as the result of the horrible abuse he suffered. This made it impossible for Reid to thrive in a traditional school setting. While in our foster care program, Reid enrolled at BRIDGES. He began to succeed academically, while learning to cope with his prior trauma and subsequent aggression. While at BRIDGES, Reid was adopted by his loving foster family. The BRIDGES staff and foster care staff helped him adjust to his new life with his forever family. Reid has grown into a wonderful young man.*

# FISH

Family Innovative Supportive Housing (FISH) is a collaboration between the Children's Home of York, Y Community Development Corporation and the York County Office of Children, Youth and Families. FISH serves families with children who are homeless/near homeless. Families are provided stable housing immediately — then other issues impacting the household's ability to become self-sufficient are addressed over the course of one year. The program includes individual case management for each family, mandatory life skills instruction, progress meetings, coordination with community services and assistance agencies, a membership to the YMCA, and development and implementation of a plan to achieve permanent housing following completion of the program.

*When Marta was referred to the FISH Program she was coming out of an abusive marriage. Over the course of a year, Marta and her son utilized the resources available through FISH to embark on a new and better life. Marta graduated from beauty school and earned a position as a stylist at a local salon. Marta saved her money and purchased a car. She addressed the issues of domestic violence in counseling sessions and worked hard to form new, healthy relationships. Marta found joy working out at the YMCA and spending time with her son there. When she completes the program next month, Marta will be moving into an apartment of her own with the resources to sustain her housing and employment.*

*Christine struggled with substance abuse, mental health issues, and family relationships. She was quiet, withdrawn, and rarely made eye contact with staff. Christine and her family actively participated in her treatment process. As she progressed, Christine became more assertive and began making eye contact with staff and peers. Gradually, her confidence increased. A fun sense of humor emerged, and Christine built positive relationships with staff. She had successful home visits with her family, maintained her sobriety, and worked hard to develop a discharge plan that will allow her to be successful when she returns home. Christine's experience at the Girls' Center equipped her with the skills she needs to have a happy and healthy life.*

## Girls' Center

Our Girls' Center is a licensed, gender-specific, trauma-focused Residential Treatment Facility. We specialize in treating Post-Traumatic Stress Disorder in young women between the ages 13 and 18. While in our care, girls receive individual, group, and family therapy as appropriate, as well as educational services. Girls' Center residents also learn independent living skills and effective coping skills through therapeutic exercises, including the expressive arts, yoga, and participating in an Equine Assisted Psychotherapy (EAP) program.

# Independent Living

## AT GEORGE STREET



Independent Living at George Street is a community-based therapeutic program. Young men between the ages of 14 to 18 develop the skills they need to live on their own. Residents attend school or other educational programs; receive vocational and independent living skills training; and benefit from an individualized program of socialization and treatment services.

*When Eric entered the program, he was behind in school, had significant probation fines to pay, and a community service obligation to complete. While at George Street, Eric prepared for and passed his GED test. Additionally, he began an internship at the Yorktowne Hotel as an apprentice chef. As a result of his hard work, Eric earned a full time position at the Yorktowne. He also found another job at a local Subway. He completed his community service hours by volunteering weekly at the York County Food Bank. Eric also saved his entire income throughout his placement so he was able to pay his probation fines and find a home of his own.*

*After being physically aggressive with her mother and running away from home, Becky struggled through a series of failed placements. Becky came to the Children's Home's MTFC program after being caught with alcohol at school.*

*Through her work with MTFC therapists, Becky mended relationships with her parents and siblings, and learned to function as part of a healthy family. She learned to set boundaries, respect her parents' authority, and correct her mistakes. Becky completed the program and was reunited with her family.*

## MTFC™

Multidimensional Treatment Foster Care (MTFC™) provides a community-based treatment alternative to institutionalization or incarceration for adolescent boys and girls aged 12 to 17. Our MTFC team utilizes a strengths-based approach with the goal of stabilizing the client's behavioral and emotional symptoms while providing treatment services in a family setting. Each client's plan of care is designed to simultaneously prepare the client and his/her parents, relatives, or other aftercare resources for reunification or independent living — with treatment, therapy, skill training, academic assistance, and the development of an aftercare plan and support system designed to sustain long-term positive change.

# Permanency Program

Permanency Program (Foster Care & Adoption) provides a variety of services for children from birth through the age of 18 and their biological, foster, and/or adoptive families. Our structured therapeutic family environment offers intensive support with the goal of helping children in our care secure a permanent, loving forever family as quickly as possible. This might mean providing services that facilitate reunification with the biological family or preparation and support in transitioning to foster care, kinship care, or adoption. We work with a diverse pool of resource parents to provide kinship care and a variety of Permanency support services. When children are approaching the age of 18, we help them transition to independent living.

Children's Home of York and Permanency Partners, a division of the Children's Home of York in the South East Region of Pennsylvania, are affiliate agencies of the Statewide Adoption Network (SWAN) and offer a full range of adoption services including child and family profiles, preparation and recruitment, finalization, support groups, post-placement supervision, and respite care.

## Foster Care:

*For almost five years, Michelle has lived in a Children's Home foster home. While in foster care, Michelle's father passed away while incarcerated, her brothers were previously adopted, and her sister is in a residential treatment program. Michelle has thrived in her foster home despite the challenges she has faced from a young age. Now a senior in high school, she attends church and does volunteer work. She has excelled at Track and Field, Junior ROTC, and the saxophone and viola. Michelle has received three college acceptance letters and plans to enlist in the Army National Guard. Her foster family will continue to be her lifelong family.*

## Adoption:

*A brother and sister came into the care of the Children's Home, each exhibiting behavioral issues. The brother did everything for his younger sister, so much so that she could not function without him. A child preparation specialist suggested separating the children to work on their individual struggles. The brother's behavior excelled — correcting behavioral, hygienic and attitude issues. The sister struggled, unable to function on her own. With extensive therapy, both siblings were able to overcome their challenges.*

*After consideration and involvement with the team, it was decided that the siblings would visit with a family who was willing to have them together. The new adoptive family was informed about their past, they were provided with supports to help them parent these children, as well as supports for the children to adjust to their new home. The Children's Home of York continued to provide child preparation to the children and worked to include the new family in this process so they would feel more like a family. The Children's Home of York also provided Finalization supports to the family to provide them with home visits to discuss the transition of the children, process paperwork necessary for the finalization to occur, and prepare for the adoption day.*

*These children now are together, the family is working as a family unit, and the children have a forever home together.*



## Strengthening Families

Strengthening Families Program is an effective, dynamic, family-focused prevention program that supports all kinds of families who care for children ages 10-15. Free to those who attend, the seven week program teaches children and their families skills they need to be a stronger, more effective family, such as building positive relationships, setting appropriate limits, and following through with consequences. Childcare is provided for children under the age of 10 whose families are enrolled in the program. Four week booster sessions are also available as a “refresher course” for anyone who has completed the initial seven week program.

*Julie and Jim wanted to change their family, but knew it wouldn't be easy. Their teenage daughter, Krystal, stopped communicating. She would come home and ignore questions about where she was or what she was doing. Julie would get frustrated and start yelling, and then a screaming match would ensue. Julie and Jim knew they had to fix their family, and they enrolled in the Strengthening Families Program. At the beginning, they had to force themselves to go and drag Krystal along. But by mid-program, they were no longer strangers. Julie and Jim realized they weren't alone in their struggle and even Krystal began enjoying the sessions. The family bonded closer together, opening the lines of communication and putting in place rules and plans to ensure a healthy family dynamic after Strengthening Families ended. Additionally, they connected and formed friendships with other families in the program. Families, like Julie and Jim's, learn how to peacefully resolve family conflict, work as a team, prevent yelling, manage stress and show affection.*

## ADDITIONAL SERVICES PROVIDED

### Evaluation Services

Evaluation Services offers an array of services for those who require assessment and review of personal psychosocial functioning — including family relationships, behavioral addictions, anger management, criminal charges, psychological, social, cognitive, and any other identified risk management possibilities. Our continuum of evaluation services includes: diagnostic evaluation, risk assessments, parenting assessments, home studies, and consideration of criminal conviction offenses in custody evaluations (5329). Our evaluation services utilize observation, historical information, surveys, standardized evaluations, and interviewing to determine the most effective plan of care and treatment for the referred individual(s). In addition, we offer complementary services such as supervised visitation with trained staff to ensure that a child is able to have safe contact with a non-custodial parent, in a comfortable setting.

### PREP

Personal Responsibility Education Program (PREP) is offered to adolescents in our BRIDGES™, Girls' Center, and Independent Living at George Street programs. We also offer the program at York County's Youth Development Center (YDC). Funded through a Pennsylvania Department of Health grant, PREP utilizes the Riker's Health Advocacy Program and Street Smart models to meet the developmental needs of the teens we serve. The program aims to reduce the number of young people who are engaged in risk taking behavior by providing them with essential knowledge, attitudes, beliefs, skills, motivation, and self-esteem needed to make healthy choices.



### Early Development

Early Development is a new initiative for young children providing a preventative approach to children birth through 5 years and their families. Research and experience proves that the earlier a child and family receive the care and support they need, the better their chances of achieving and maintaining a healthy and productive life. In collaboration with York County Early Intervention, we are helping to strengthen children and families by providing in-home social work services to families already receiving early intervention services. In-home social work services utilize a therapist to help families address barriers and challenges and connect them with the resources needed to be successful. By strengthening the family unit, the developmentally delayed child is in a stronger position to progress through treatment and make developmental strides. We are exploring expanding our services to childcare centers that need support in creating and maintaining an environment conducive to growth and learning, while supporting individual behavioral challenges.

## Community Prevention Programs

The Children's Home of York delivers Prevention Services, on behalf of the York/Adams Drug and Alcohol Commission (YADAC), which systematically address community health needs assessed by the Communities that Cares model and the needs assessment administered by YADAC. Topics include drug and alcohol consequences and prevention, family management education, tobacco and smoking cessation, and healthy brain awareness. Celebration of annual national prevention awareness campaigns also take place, including Red Ribbon Week, Drug and Alcohol Prevention Education Week, Healthy Brain Awareness Week, Family Week, National Night Out, Tobacco Education and Smoking Cessation Week, and 3-D's: Drinking, Drugging and Driving Under the Influence Prevention Week.

The Children's Home and YADAC continuously look for new programs to address community needs.

Prevention providers deliver specific evidence based strategies and programs designed to decrease the incidence of risk factors which increase the likelihood of substance abuse within our community. Services are delivered in a variety of methods which include, but are not limited to, small and large groups, classrooms, social organizations, businesses and other community non-profit settings.

## DISCONTINUED SERVICES

### START

Southeast Treatment and Reentry Team (START) was a grant-funded pilot program that enabled us to work with Bucks, Chester, Delaware, Montgomery, and Philadelphia counties to offer a reentry partnership to assist and support adolescent females in their transition out of residential care back into the community and their families. Funded through the Pennsylvania Commission on Crime and Delinquency, START helped young women heal from their past traumas and successfully return to their families and communities. START was discontinued in 2013 when grant funding ceased. We are exploring ways to offer similar services to both male and female adolescents in our community.

### STRIVE

STRIVE effectively served adolescent males struggling with addiction issues for over 30 years. However, the referral climate shifted to adolescents receiving in-home care, and STRIVE was no longer able to stay financially viable. Clients who were in the program were successfully discharged or transferred to another program before STRIVE closed in November 2013. As always, each client was treated with individualized care and attention during the transition.

### Tindall House

Tindall House was a community based therapeutic program providing residential care for young boys ages 8 to 14 who came from a life of abuse and trauma. Over the past decade, the trend of care has shifted, placing trauma survivors in emergency foster care or kinship care rather than residential programs. This provided a softer, more home-like transition for adolescents. With the decreased use of residential care, Tindall House closed in May 2013. Those still in care were adopted, reunified with their family, or transitioned to another community based program with a specified care plan designed by Children's Home therapists.
